**A RESOLUTION ADOPTING RULES AND REGULATIONS
MODIFYING DOG PARK USAGE WITHIN HARMONY
COMMUNITY DEVELOPMENT DISTRICT**

**BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF HARMONY
COMMUNITY DEVELOPMENT DISTRICT AS FOLLOWS:**

WHEREAS, the Harmony Community Development District (hereinafter the "District") is a local unit of special purpose government created and existing pursuant to Chapter 190, Florida Statutes, being situated entirely within St. Osceola County, Florida

WHEREAS, the Board of Supervisors of the District (the "Board") has the right to adopt reasonable rules and regulations to maintain parks and facilities for indoor and outdoor recreational, cultural, and educational uses within the District pursuant F.S., Chapter 190.012(2)(a).; and

WHEREAS, the District wishes to revise its rules and usage policy for the dog park(s) within its boundaries as attached hereto as Exhibit "A";

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Harmony Community Development District as follows:

1. The above recitals are true and correct and incorporated herein by reference.
2. The modified rules for the use of dog parks within District boundaries set forth on attached Exhibit "A" are hereby adopted pursuant to this Resolution. These rules shall stay in full force and effect until such time as the Board of Supervisors may amend these rules in accordance with Chapter 190, Florida Statutes.
3. District Manager has provided notice to the general public in accordance with Section 190.035(2), Florida Statutes, and scheduled a Public Hearing before the Board of Supervisors.
4. If any provision of this Resolution is held to be illegal or invalid, the other provisions shall remain in full force and effect.
5. The Resolution shall become effective upon its passage and shall remain in effect unless rescinded or repealed.

EXHIBIT A

Harmony CDD Rules & Policies

7.3.4 Dogs must be on leashes while entering or exiting a dog park. Handlers must, at all times, have possession ~~on~~ **[of]** the leashes of their dogs.

7.3.6 Handlers acting alone must be ~~sixteen (16)~~ **[twelve (12)]** years of age or older.

7.3.7 The maximum number of dogs per handler is ~~two (2)~~ **[six (6)]**

7.3.12 Children younger than ~~twelve (12)~~ **[eight (8)]** years of age must be supervised by an adult while within the confines of an off-leash dog park.
