Background

The AMSCD received permission from the Board in late 2014 to go out to bid for the landscape services contract, which is currently being performed by TrueGreen Landscaping. After speaking with several prospective bidders it became apparent that there may be cost savings achieved if both the contracts for the AMSCD and the Ave Maria Master Association (Master) were bid at the same time. This made sense because both contracts are supervised by the same people and covers similar common areas.

The bid responses for both were strong with nine companies submitting bids and noting the lowest four bidders were all within 10% of each other. The bid responses sheet is attached.

The following four firms were invited to make a presentation to the selection committee:

- 2. Gulfscapes
- 3. Luke Brothers
- 4. Mainscape

The selection committee consisted of:

- 3. Donny Diaz, Ave Maria Master Association

The selection committee determined on the following criteria and point totals:

Each firm met with the selection committee for approximately 20 minutes, including questions and answers. After each firm presented the selection committee discussed the qualifications and responses and each committee member scored the firm separately.
